GKCIET Entrance Test (GET)-2020: Admission to Diploma Programs

Ghani Khan Choudhury Institute of Engineering and Technology, Malda will conduct All India GKCIET Entrance Test (GET) 2020 to provide admission in 50 % available seats for students from other states and UT excluding West Bengal (i.e., 105 plus EWS) in above Diploma courses of the Institute for the session of 2020-21, following reservation policy as per Government of India.

Eligibility: Passed/appeared in 10th standard with English, Physical Science/Science (Physics and Chemistry) and Mathematics from any recognized Board/Council/Institute with at least 35% marks (without additional subjects & rounding-up) at the qualifying examination. In case of appeared candidates, pass certificate mark sheet and migration/school leaving certificate are to be submitted at the time of admission. Should not be born after 01/07/2005 and there is no upper age limit.

Syllabus: Latest revised syllabus on Mathematics and Physical Science up to Class X under any recognized Board/ Council/ Institute and will be provided in information brochure. Type of question paper will be multiple choice questions (MCQ).
